RESOLUTION NUMBER R-276627

ADOPTED ON OCTOBER 1, 1990

WHEREAS, the Public Facilities and Recreation Committee, at its meeting of June 13 and June 27, 1990, recommended uses of certain City-owned vacant land to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Public Facilities and Recreation Committee recommendations on those City-owned sites numbered 9A, 10A, 11A, 14A, 232, 254, 255, 289, 332, 364, 405, 407, 441, 456, 495-B, 499-B, 501, 502, 503, 504, 505, 506, 507, 508-A, 531, 557, 558, 573, 586, 605, 619, 665, 669-B, 673, 757 and 813, as shown on that Document No. RR-276627 in the office of the City Clerk, are hereby approved.


BE IT FURTHER RESOLVED, that the City Council, by making the above designation, in no way intends to bind itself to utilize the property in accordance with the designation, and the Council specifically intends to be able to change the designation at any time or utilize the property for any purpose determined to be in the best interest of the City at the sole discretion of the Council.

BE IT FURTHER RESOLVED, that this designation serves simply and exclusively as a tentative guide to the City staff with regard to potential use of vacant City-owned land and that it is the Council's intent that this designation and past designations
