RESOLUTION NUMBER R- 276635

ADOPTED ON OCT 01 1990

WHEREAS, "Hands Across Our Beaches" is an effort by people from throughout California to demonstrate their support for protection of the state's coastal waters, beaches and air; and

WHEREAS, our continued dependence on fossil fuels without the benefit of a national energy policy emphasizing energy efficiency jeopardizes our national security; and

WHEREAS, the proposal to conduct oil drilling in federal waters along the San Diego coastline merely perpetuates this dependence and endangers the environment and economy of San Diego; and

WHEREAS, people will be joining together on October 7, 1990 to join their hands across the beaches on the California coast in support of a strong national energy policy emphasizing conservation and in opposition to offshore oil drilling along the San Diego and California coastline; and


WHEREAS, our varied coastline provides a rich scenic recreational, cultural and historical heritage, and our marine environment is one of the most valuable resources for recreation, tourism, fishing and other coastal industries; and

WHEREAS, The City of San Diego is strongly committed to the wise management of the coastline to ensure that the environmental and economic value of the coastal zone will be sustained; and

WHEREAS, preserving the productivity and quality of coastal resources requires public awareness and support and an understanding that protection of the coast is a responsibility shared by individual citizens, the business community and public institutions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that October 7, 1990 be and it is hereby proclaimed to be "HANDS ACROSS OUR BEACHES DAY" in San Diego and encourages all the people of San Diego to join in the celebration of this special event.
