BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Stephen L. Hayes, Licensed Land Surveyor, entitled "PARCEL MAP NO. W.O. 870103 being a division of Lot 4 of Oliver-McMillan Miramar Industrial according to Map thereof No. 11620 filed in the Office of the County Recorder of San Diego County September 17, 1986 in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Miramar Road, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Miramar Road, adjacent and contiguous to a portion of Parcel 1 & 2, all as shown on the map within this Parcel Map.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map,
