WHEREAS, the Council of The City of San Diego, by Resolution No. R-273354, adopted on May 1, 1989, approved the Articles of Incorporation of the San Ysidro Revitalization Project, a California nonprofit corporation (herein called "Corporation"); and

WHEREAS, The City of San Diego is the sole member of the Corporation, acting through the Council pursuant to appropriate law; and


WHEREAS, the City Attorney for The City of San Diego has been authorized to submit Corporation's Articles of Incorporation and Bylaws to the Secretary of State in accordance with the California Corporations Code; and

WHEREAS, it has been determined that the Articles of Incorporation should be amended to provide for federal nonprofit status; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the amended Articles of Incorporation of the San Ysidro Revitalization Project are hereby approved, copies of said Articles of Incorporation are on file in the office of the City Clerk as Document No. RR- 276644.

BE IT FURTHER RESOLVED, that the City Attorney is hereby authorized to file said amended Articles of Incorporation with the appropriate state and federal agencies.
