WHEREAS, the network includes the Association for Retarded Citizens, the Community Service Center for the Disabled, the Deaf Community Services, Mainstream Magazine, The Muscular Dystrophy Association, The San Diego Service Center for the Blind, the University of California, San Diego, Disabled Student Services, and the People Resources for Disability Efforts; and

WHEREAS, the network hopes through Disability Awareness Network Week to educate people on various types of disabilities and on proper etiquette and terminology when interacting with people with disabilities; and

WHEREAS, through Disability Awareness Network Week (October 1 through 5, 1990) the network hopes to develop public awareness about the fact that a person with a disability is a person first, who just happens to have a disability; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the week of October 1 through 5, 1990 be and it is hereby declared to be "Disability Awareness Network Week" in San Diego.

BE IT FURTHER RESOLVED, that the Disability Awareness Week Network be and is hereby commended for its efforts in bringing this to public attention and for its efforts to dramatize the importance of understanding the world of those persons with disabilities.
