A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO SELECT RECOMMENDED BOUNDARIES FOR THE NORTH PARK REDEVELOPMENT PROJECT AREA.

WHEREAS, the Council of The City of San Diego (the "City Council") by Resolution No. 273593, adopted on May 30, 1989, approved a redevelopment survey area for the North Park community to study and determine the feasibility of a redevelopment project or projects therein; and

WHEREAS, the City Council by Resolution No. 275708, adopted on May 14, 1990, approved amended boundaries for the North Park Redevelopment Survey Area; and

WHEREAS, the City Council has reviewed the results of a field study prepared to study the feasibility of redevelopment in the North Park community, and desires to designate a project area within the survey area and requests the Planning Commission of The City of San Diego (the "Planning Commission") to select the project area boundaries; and


WHEREAS, the Planning Commission, in accordance with the California Community Redevelopment Law (Health and Safety Code sections 33000, et seq.) will select a project area for the proposed North Park Redevelopment Project and will adopt a Preliminary Plan therefor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby requests the Planning Commission to select the boundaries for the North Park Redevelopment Project Area as shown

on the map of project area (attached hereto and incorporated herein as Exhibit A).
