RESOLUTION NUMBER R-276652

ADOPTED ON OCT 01 1990

WHEREAS, the General Assembly of the United Nations has designated the first Monday in October as "WORLD HABITAT DAY"; and

WHEREAS, the United Nations Center for Human Settlements has urged all concerned with the development of a safe, decent living environment for the poor to commemorate World Habitat Day; and

WHEREAS, the City Council is concerned to ensure an adequate supply of affordable housing for all San Diegans; and

WHEREAS, the region is being urbanized at a rapid rate and the supply of land to house the poor is becoming scarce; and

WHEREAS, the urban poor must have access to affordable housing and services if they are to be productive members of society; and

WHEREAS, the affordable housing shortage in the city is causing more San Diegans to live further from their place of work, increasing travel to work time and exacerbating related problems such as air pollution and traffic congestion; and

WHEREAS, many San Diegans are currently housed in substandard or overcrowded housing or are homeless; and

WHEREAS, alternative and positive solutions to adequately house all San Diegans must be found; and

WHEREAS, creative solutions to the housing crisis in other parts of the world are being sought through increasing public

awareness of the problem and forging strong public/private partnerships which are committed to expanding affordable housing opportunities; NOW, THEREFORE,
