BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby accepts the donations from the friends of Dusty Rhodes to fund the construction of a children's playground at the Collier-Sunset Neighborhood Park in Ocean Beach.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to establish a Dusty Rhodes Memorial Trust Fund to finance the children's playground project.

BE IT FURTHER RESOLVED, that for and on behalf of the citizens of San Diego, the Council expresses its appreciation to Lois Rhodes and the friends of Dusty Rhodes for their generous donations totaling over \$15,000 for this playground project.
