
WHEREAS, in Closed Session on September 11, 1990, the City Council, by unanimous vote: Yeas, Districts 1, 6, 7, 8 and the Mayor; Not Present, Districts 2, 3, 4 and 5, approved the following; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. R-275602 which approved settlement of San Diego Superior Court Case No. 565318, Dorothy Trevor v. City of San Diego, et al., be amended and that an additional \$30,000.00 is hereby authorized for the acquisition of a drainage easement on the Trevor property. This \$30,000.00 is in addition to the \$85,000.00 already approved for a total of \$115,000.00 in full settlement of the above-entitled action, and

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he hereby is authorized to issue two (2) checks: one in the amount of \$90,000.00 made payable to Aetna Life and Casualty and the second check in the amount of \$25,000.00 made payable to Dorothy Trevor.
