ADOPTED ON OCTOBER 8, 1990

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE APPLICATION AND ASSURANCES FOR GRANT FUNDING UNDER THE COASTAL CONSERVANCY ACCESS PROGRAM FOR THE DEVELOPMENT OF A PHYSICALLY CHALLENGED PLAY AREA AT TECOLOTE SHORES.

WHEREAS, the Legislature has established the State Coastal Conservancy pursuant to California Public Resources Code sections 31000 - 314000, and has authorized it to award grants to local public agencies and nonprofit organizations for the acquisition and development of coastal accessways; and

WHEREAS, grants are awarded pursuant to guidelines established by the Coastal Conservancy for determination of project eligibility for funds; and

WHEREAS, the procedures established by the Coastal Conservancy require the applicant to certify by resolution its approval of the application and listed assurances prior to its submission of the application to the state; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager or his representative be and he is hereby authorized to submit an application to secure State Coastal Conservancy funding as described in the Council docket supporting information.

2. That the Council certifies that it understands the assurances and certifications contained in the application.

3. That the Council certifies that it has or will have sufficient funds to operate and maintain the project funded under this program.

4. That the Council certifies that the estimated cost is correct as nearly as possible and that the City has sufficient funds including the Conservancy Grants to complete the project.

5. That the City Manager or his representative be and is authorized to coordinate, process and execute all contracts, agreements, amendments and ancillary documents within the scope of the letter of transmittal.

6. That the City Auditor and Comptroller be and is hereby authorized to establish special funds which will earn their own interest in accordance with grant requirements.
