- (B) \$153,600 from CIP 37-237.0, Community Service Center for the Disabled, CDBG Fund 18526, Department 5892, Organization 9206; and

(C) \$24,500 from CIP 37-234.0, Bayside Settlement House, CDBG Fund 18526, Department 5892, Organization 9202.
