ADOPTED ON OCT 15 1990

WHEREAS, the United States Coast Guard celebrated its bicentennial anniversary during the week of June 2 through 8, 1990 in San Diego; and

WHEREAS, The City of San Diego, on behalf of all its citizens, recognized the Coast Guard's contributions to the city and nation; and

WHEREAS, in further recognition of the Coast Guard and the significant role it has played in the history of San Diego and the nation, it is appropriate to dedicate a public site in honor of the Coast Guard's 200 years of service to the nation; and

WHEREAS, it has been suggested such public site be appropriately associated with navigable waters such as the Harbor Drive bridge which symbolically links the Point Loma lighthouse with the Coast Guard air station; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby dedicate the Harbor Drive bridge which crosses the channel between Point Loma and the Spanish Landing Park area to the U.S. Coast Guard on the memorable occasion.

BE IT FURTHER RESOLVED, that the Harbor Drive bridge be named and hence forth known as "The U.S. Coast Guard Bicentennial Bridge" as a lasting tribute to the generations of Coast Guard

men and women whose tradition of humanitarian and military
service stands as a beacon to all people.
