WHEREAS, The City of San Diego, a municipal corporation, is the owner of a parcel of land in The City of San Diego, County of San Diego, State of California, being a lot line adjustment of Lot 8 of Eastgate Technology Park, Unit No. 1, according to map thereof No. 10830 on file in the office of the County Recorder of San Diego, Lot 9 of Eastgate Technology Park, Unit No. 2, according to map thereof No. 11498 on file in office of the County Recorder of San Diego, and portions of Pueblo Lots 1318 and 1351 of the Pueblo Lands of San Diego according to map thereof made by James Pascoe in the year 1870, a copy of which said map being filed in the office of the County Recorder of San Diego and is known as Miscellaneous Map No. 36 in the City of San Diego, County of San Diego, State of California, together with Eastgate Mall, Judicial Drive, portions of Towne Centre Drive and Nexus Centre Drive, and the pedestrian and nonmotor vehicle right of way as dedicated to public use, and Miramar Road and portions of Eastgate Mall as closed and vacated to public use; and


WHEREAS, said City proposes to file a subdivision map of said area to be known as Parcel Map W.O. No. 890993; and

No. 890993 consenting to the preparation and recordation of said map.
