WHEREAS, the San Dieguito River Valley Regional Open Space Park Joint Powers Authority (the JPA) has endorsed the expanded San Dieguito Lagoon Resource Enhancement Program (the plan) for the Coastal Zone area of the Focused Planning Area for the San Dieguito River Valley Regional Open Space Park (the park); and

WHEREAS, the plan provides for natural resource protection and enhancement as well as recreation facilities; and

WHEREAS, it is necessary to determine the feasibility of the plan in order to assemble land for this area of the park and provide more specific information for future consideration; and

WHEREAS, the JPA has determined that the Coastal Zone portion of the park is an area of high priority for park planning and implementation; and

WHEREAS, approximately half of the Coastal Zone portion of the park is within the City of San Diego (the City); and

WHEREAS, the JPA and its member agencies, including the City, have funded conceptual planning to date and the JPA is funding detailed planning for high priority inland portions of the park; and


WHEREAS, the State Coastal Conservancy (the Conservancy) is a State Agency that can provide funding and technical assistance to local agencies to undertake natural resource protection and enhancement planning that incorporates public recreational facilities and to implement such plans; and

WHEREAS, the JPA has formally requested that the Conservancy provide such funding and technical assistance to the JPA; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego hereby expresses its support for the JPA's request that the State Coastal Conservancy provide funding and technical assistance to the JPA for the purposes of preparing a natural resource protection and enhancement plan that incorporates public recreation facilities consistent with the concept plan for the expanded San Dieguito Lagoon Resource Enhancement Program.
