RESOLUTION NUMBER R- 276726

ADOPTED ON OCT 16 1990

WHEREAS, this Council wishes to strengthen housing inspection and code enforcement and improve drug abatement efforts in relation to the Housing Code and regulated housing (San Diego Municipal Code, Chapter IX, Article 8, Division 1; and

WHEREAS, the cost of these services can and should be fully recovered by fees to the greatest extent possible; and

WHEREAS, costs related to the funding of the City's drug abatement program should be added as a surcharge to the annual housing permit fee in order to enhance housing code enforcement; and

WHEREAS, this Council wishes to encourage and support public assisted housing through appropriate waivers of housing permit fees where applicable; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby directed to implement a program of aggressive drug abatement enforcement through the establishment of a Drug Abatement Response Team (DART) in areas of the City where priority enforcement is necessary.

BE IT FURTHER RESOLVED, that the fees listed in the Fee Schedules attached hereto as Attachments A and B and which establish or revise the following categories of fees, are hereby approved, and the City Manager is directed to implement them on January 1, 1991:


1. A new housing permit fee for one and two-unit housing establishments;
2. A revised housing permit fee for housing establishments of three or more units;
3. A revised penalty fee for delinquent payment and nonpayment of the annual housing permit fee;
4. A surcharge to be added to the annual housing permit fee to support the funding of a full time Drug Abatement Response Team (DART).

BE IT FURTHER RESOLVED, that those fees identified on Attachment A as existing fees shall continue to be charged by the City Manager on a current basis without regard to the effective date of other fees.

BE IT FURTHER RESOLVED, that the City Manager shall exempt public assisted housing units from payment of the annual housing permit fee upon presentation of satisfactory proof of such entitlement.

FEE SCHEDULE

1. Housing permit fee for one and two-unit housing establishments:

A fee of \$18.00

2. Housing permit fee for apartments, condominiums and Single Room Occupancy (SRO) hotels containing three or more units, as shown in Attachment B, based on the following scale:

An average of \$4.46 per unit, on a sliding scale basis ranging from \$18 for a three (3) unit establishment (\$6 per unit), to \$1,860 for a five hundred (500) unit establishment (\$3.72 per unit), to \$3,360 for a one thousand (1,000) unit establishment (\$3.36 per unit).

3. An annual housing permit fee surcharge of \$1.00 per rental housing unit shall be added to the above fees to support the funding of the drug abatement enforcement program (DART).

NOTE: The Housing Permit Fee Schedule attached as Attachment B details the annual fee for each establishment listed in sections 1, 2 and 3 only by number of units and includes the surcharge.

4. Housing permit fee for each hotel (other than Single Room Occupancy (SRO)) containing more than 15 units, shall be \$15.00 plus forty (.40) cents for each unit in excess of 15. No surcharge shall apply (existing fee).

5. Fee for reinspection services:

\$50.00 per hour (existing fee).

6. Fee for transfer of ownership and issuance of a revised

housing permit:

\$15.00 per transfer (existing fee).

7. Penalty fee for operating a housing establishment without a housing permit: a flat fee of one hundred dollars (\$100) for an establishment containing up to ten units, and for those establishments containing eleven (11) or more units, a fee of one hundred dollars (\$100) plus ten dollars (\$10) for each dwelling unit within that establishment. An additional fee shall be imposed at the rate of twenty percent (20%) of the Annual Housing Permit fee per month for each month or portion thereof that the establishment is operated without a permit for more than thirty (30) days.

8. A penalty fee for delinquent payment of the annual housing permit fee shall be imposed at the following rate: a flat fee of one hundred dollars (\$100) for an establishment containing up to ten units, and for those establishments containing eleven (11) or more units, a fee of one hundred dollars (\$100) plus ten dollars (\$10) for each dwelling unit within that establishment. An additional fee for delinquent payment of the annual housing permit fee shall be imposed at the rate of twenty percent (20%) of the Annual Housing Permit fee per month for each month or portion thereof that the payment is delinquent by more than thirty (30) days.
