BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay the sum of \$37,500.00 in the settlement of each and every claim against the City of San Diego, its agents and employees, in Superior Court Case No. 614157, Terilynn Danner v. City of San Diego, et al., resulting from a vehicle accident in which the plaintiff was rear—ended by a City Park and Recreation employee in the City's Chevy S-10 stakebed truck. She was stopped at a stoplight when our employee rear—ended her car at 20 m.p.h. The plaintiff has suffered a permanent disability injury to her lower back resulting from this accident and is currently on state disability. The plaintiff will require occupational rehabilitation training as a result of this injury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$37,500.00, made payable to Terilynn Danner, and her attorney of record, Randall B. Hamud, in full settlement of all claims.
