WHEREAS, the people of The City of San Diego recognize that violence is inherent in pornography, especially against women and children; and


WHEREAS, the people also recognize that only the consensus of a community can determine the standards of public decency; and it is incumbent upon the people of this city, led by our City Council, to fully understand the impact of pornography in our society and to take action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby proclaims October 28 to November 4, 1990 as "PORNOGRAPHY AWARENESS WEEK" in The City of San Diego.

BE IT FURTHER RESOLVED, that this Council hereby endorses the WRAP (White Ribbons Against Pornography) national campaign against pornography.
