BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF STORM DRAIN ON EADS AVENUE AND FRIARS ROAD CHANNELIZATION SIGNS - ATTENUATOR ASSEMBLY, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on OCT 29 1990, and bearing official Document No. W.O. 119356/119634, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF STORM DRAIN ON EADS AVENUE AND FRIARS ROAD CHANNELIZATION SIGNS - ATTENUATOR ASSEMBLY.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer of \$29,420 from Capital Outlay Fund No. 30245, CIP No. 58-004, ANNUAL ALLOCATION - MISCELLANEOUS REQUIREMENTS, CITY STREETS, to CIP No. 62-274, FRIARS ROAD CHANNELIZATION SIGNS - ATTENUATOR ASSEMBLY.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$149,320 (\$110,000 from DIF Fund No. 79514, CIP No. 11-278, EADS AVENUE DRAIN, and \$39,320 from CIP No. 62-274, FRIARS ROAD CHANNELIZATION SIGNS - ATTENUATOR ASSEMBLY), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
