WHEREAS, NEXUS CENTRE/TORREY PINES ASSOCIATES, a California limited partnership, has requested an exchange of water easements in Parcels 1 and 2 of Parcel Map No. 15700 in exchange for a water easement previously granted to the City; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and


WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Manager or his designee be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-276768 quitclaiming to NEXUS CENTRE/TORREY PINES ASSOCIATES, all of the City's right, title and interest in the water easement in Parcels 1 and 2 of Parcel Map No. 15700, as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause the quitclaim deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
