



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to the Agreement with FEDERHART & ASSOCIATES to provide additional funding of \$50,000 to extend their existing contract to provide Traffic Engineering Consultant Services, as needed, for the Water Utilities Department, under the terms and conditions set forth in the Amendment on file in the office of the City Clerk as Document No. RR-276781.

BE IT FURTHER RESOLVED, that this additional expenditure of an amount not to exceed \$50,000 consisting of \$25,000 from the Water Operating Fund (No. 41500), Water Operation Engineering Program (No. 70830); and \$25,000 from the Sewer Revenue Fund (No. 41506), Sewer Operation Engineering Program (No. 70820), is hereby authorized, solely and exclusively for the purpose of providing funds for the above Amendment.
