



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a three-year Use and Occupancy Permit (with a three-year renewal option) with PETROLANE GAS SERVICE, for approximately 5,000 square feet of property located at Kearny Mesa Road and Magnatron Boulevard for the storage of four 1,150-gallon, aboveground LPG tanks for servicing contract customers, at an initial monthly rent of \$1,900, under the terms and conditions set forth in that Use and Occupancy Permit on file in the office of the City Clerk as Document No. RR- 276782 .
