
BE IT FURTHER RESOLVED, that Change Order No. 6, dated October 4, 1990, heretofore filed with the City Clerk of said City as Document No. RR-276787-2, issued in connection with the above referenced contract, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$41,878.00.

BE IT FURTHER RESOLVED that the City Auditor is hereby authorized to transfer an amount not to exceed \$100,000 from Capital Outlay Fund 30244, CIP 90-245.0, Capital Outlay - Unallocated Reserve, Capital Outlay Other Reserve Fund 302453 to

CIP 29-600.0, Ocean Beach Pier Rehabilitation, solely and exclusively for the purpose of funding this change order.
