
ADOPTED ON OCTOBER 30, 1990

WHEREAS, on October 30, 1990, the Council of The City of San Diego considered the appeal of Vista Hill Foundation, by David F. Dunbar, of Hyatt and Rhodes, from the decision of the Historical Site Board in approving historical site designation of the William Clayton House located at 545 Laurel Street. Specifically, the area designated being the exterior of the building and the rear garden/patio/driveway and cobblestone wall, as Site No. 257, Grade 1; and

WHEREAS, in arriving at their decision the City Council considered the decision of the Historical Site Board, the staff report and the materials submitted prior to and at the public hearing and heard public testimony presented at the hearing; and

WHEREAS, the City Council found that historical site designation of the William Clayton House was warranted because of its architect, Hazel Waterman, a significant architect in San Diego, and because it is a landmark in the Uptown community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of the Vista Hill Foundation is hereby denied and the decision of the Historical Site Board in designating the




