ADOPTED ON OCT 30 1990

TO TERMINATE THE PROCESSING OF A COMMUNITY
PLAN AMENDMENT AND RELATED REZONING FOR
AREA A IN THE MID-CITY COMMUNITY PLANNING
AREA.

WHEREAS, the proposed amendment to the Mid-City Community Plan would redesignate a section of the Kensington Neighborhood (Area A), at the intersection of Marlborough Avenue and Hilldale Drive, from Neighborhood Commercial to Low Density Residential and rezone the area from CN to R1-5000; and

WHEREAS, on November 16, 1989, the Planning Commission of The City of San Diego held a public hearing to consider the community plan amendment and related rezone for Area A; and

WHEREAS, the Planning Commission recommended approval of Area A to be redesignated from Neighborhood Commercial to Low Density Residential and rezone from CN to R1-5000; and


