ADOPTED ON OCTOBER 30, 1990

WHEREAS, San Diego Municipal Code sections 98.0501 et seq. relates to the provision for and preservation of affordable housing in San Diego; and

WHEREAS, section 98.0513 creates a Housing Trust Fund Board of Trustees consisting of eleven (11) members to assist the Housing Commission in the administration of the Housing Trust Fund; and

WHEREAS, sections 98.5014 and 98.0515 provide for the qualification and selection of the trustees; and

WHEREAS, said selection shall be made by the Mayor from selected areas of interest and confirmed thereafter by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the following appointments by the Mayor of The City of San Diego to serve as trustees of the Housing Trust Fund, to represent categories as shown, for terms to expire as indicated, be and the same are hereby confirmed:


