ADOPTED ON OCT 30 1990

WHEREAS, sewage in the Tijuana River has been impacting on the San Diego area for over fifty (50) years; and

WHEREAS, the San Diego Border Task Force was formed in 1985 to address this problem and the problem of mosquito abatement; and


WHEREAS, the United States and Mexican governments recently signed an agreement to treat and dispose of sewage by using international facilities which are to be completed by 1995; and

WHEREAS, temporary solutions to the sewage problem need to be found while the international facilities are being completed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to continue working with the San Diego Border Task Force to implement an interim solution to the problems caused by the flow of raw sewage in the Tijuana River, as set forth in City Manager's Report No. 90-451.
