1. BARSOTTI'S INC. for the primary contract; terms 2% 10 days, with options to renew the contract for three (3) additional six (6) month periods, with option period price increases not to exceed 25% of the prices in effect in each prior contract period.
2. INSULTEC INC. for the secondary contract; terms 2% 10 days, with options to renew the contract for three (3) additional six (6) month periods, with option period price increases not to exceed 10% of the prices in effect in each prior contract period.
