WHEREAS, The City of San Diego has in past years provided off-duty police officers to assist high school personnel with security at their regularly scheduled night football games and,

WHEREAS, previous agreements between the City, the San Diego Unified School District, Sweetwater Union High School and Poway Unified School District providing off-duty police officers to assist high school personnel with security at their regularly scheduled night football games has proven to be a satisfactory arrangement which the San Diego Police Department feels should be continued; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, three (3) separate agreements with the Sweetwater Union High School District, Poway Unified School District and Torrey Pines High School, to provide a minimum of two (2) San Diego police officers at each regularly scheduled night home football game at Montgomery High School, Southwest High School, Mt. Carmel High School, Rancho Bernardo High School and Torrey Pines High School during the period of January 1, 1990, through December 31, 1995, under the terms and

conditions set forth in the three (3) agreements on file in the Office of the City Clerk as Document Numbers RR- 276824-1, RR- 276824-2, RR- 276824-3 respectively.
