RESOLUTION NUMBER R- 276840

ADOPTED ON NOV 13 1990

BE IT RESOLVED, by the Council of The City of San Diego that the contract with VOICE & VIDEO, INC. for furnishing a sixty (60) month LEASE/PURCHASE OF AUDIO/VISUAL EQUIPMENT as may be required; the purchase price of the equipment to be \$267,079.25, total lease payment to be \$324,613.20, per payment rates on file in the Purchasing Department, payable monthly in advance; lease subject to termination at the end of any fiscal year per terms of bid should funds not be appropriated by the City Council; City to assume title to equipment at end of the sixty (60) month period; with option of upgrading any item of equipment at end of two (2) years at renegotiated prices with adjustments for trade-in value; failure to reach an agreement acceptable to the Purchasing Agent shall permit termination of that portion of the contract without penalty to the City, which was authorized by Resolution No. R-276173, adopted on July 23, 1990 is hereby rescinded.

BE IT FURTHER RESOLVED, that the Police Department be permitted to pursue other options in acquiring the necessary audio/video equipment.
