
WHEREAS, on November 13, 1990, the Council of The City of San Diego held a public hearing to consider the appeal of Dr. Stanley E. Willis II, by Michael Sidley Evans, Attorney, and Marie Burke Lia, Attorney, from the decision of the Historical Site Board in approving historical site designation of the Park Manor Apartment Hotel as Site No. 251, Grade 1. The subject property is located at 525 Spruce Street, San Diego, California; and

WHEREAS, the City Council considered the plans and materials submitted prior to and at the public hearing, staff report, decision of the Historical Site Board, and public testimony presented at the hearing; and

WHEREAS, the City Council found that the Park Manor Apartment Hotel had historic and architectural merit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of Dr. Stanley E. Willis II is hereby denied and the decision of the Historical Site Board is affirmed, however said designation shall be stayed until January 23, 1991, subject to the following conditions:

1. That the City Council receive a letter from Dr. Willis or his designee, guaranteeing that no work will be done on the

2. That the City shall not issue any permits for demolition or give any approvals for substantial alteration of the property during the period of the stay.
