WHEREAS, the San Diego Public Library has been determined by the California Department of Education to be eligible to receive \$7,570 in available funding under the Federal Adult Education Act, P.L. 100-297, which encourages the expansion of basic literacy services; and

WHEREAS, these funds will assist READ/San Diego, the Library's literacy program, to continue to train new volunteers and to coordinate citywide literacy instruction; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered, for and on behalf of said City, to accept a local assistance grant of \$7,570 from the California State Department of Education to supplement adult literacy services provided by the Library Department.

BE IT FURTHER RESOLVED, that the City Manager or his duly authorized representative be and is hereby authorized to perform all acts necessary to secure and administer said grant funds.


