ADOPTED ON NOV 19 1990

WHEREAS, the Automated Regional Justice Information System was established in 1981 under a Joint Powers Agreement (JPA) with the County and all municipalities in the county; and

WHEREAS, the system is a regional computerized law enforcement data base which provides access to all law enforcement agencies in the county; and

WHEREAS, the JPA has not been revised since its inception but is now proposed that it be revised to include: a formula for reimbursement of directors for board meeting attendance, a formula for determining weighted voting based on participating jurisdiction population, and a clause enabling the Board of Directors to call for annual certification of information regarding compliance with the provisions of federal and state privacy laws; and

WHEREAS, it is necessary and required that the revised JPA be approved by the member agencies, including The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor be and she is hereby authorized and empowered to execute, for and on behalf of said City, the revised Joint Powers Agreement (JPA) for the Automated Regional Justice Information System (ARJIS) pursuant to the terms and conditions to the terms

and conditions of the ARJIS JPA, a copy of which is on file in
the office of the City Clerk as Document No. RR- 276872 .


