BE IT RESOLVED, by the Council of The City of San Diego, that the Council accepts City Manager Report No. 90-437 and authorizes the City Manager to:


A) proceed with further geotechnical design and environmental evaluation of the three sites identified within the City of San Diego as potential landfill sites;

B) execute a Third Amendment to the Joint Exercise of Powers Agreement Between The City of San Diego and the County of San Diego for a Landfill Siting Study in the Southwest Quadrant of the County, to fund and conduct geotechnical, preliminary design and environmental reports on the three sites, under the terms and conditions set forth in that third amendment on file in the office of the City Clerk as Document No. RR- 276874; and

C) continue the City's participation on the Citizen's Advisory Committee.


