

RESOLUTION NUMBER R-276881

ADOPTED ON NOVEMBER 19, 1990

BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF PUBLIC SAFETY COMMUNICATIONS - PROJECT RADIO TOWERS AND MONOPOLES/VARIOUS LOCATIONS, San Diego, California, on file in the Office of the City Clerk of San Diego, California on NOV 19 1990, and bearing official Document No. U.O. 119636, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Manager is directed to work with the Mission Trails Regional Park Task Force to develop alternative plans for utilizing existing, modified, or new facilities at the current Cowles Mountain communications site at the termination of the existing lease with Cox Cable. These alternatives shall provide future facilities which shall accommodate essential public communications requirements while minimizing environmental effect and shall also consider the impact of allowing the continued occupancy of commercial broadcasting interests at the Cowles Mountain communication site.

BE IT FURTHER RESOLVED, that the sole acceptable bid of \$309,001.00 by TOWER STRUCTURES, INC., a California corporation, meeting specifications for CONSTRUCTION OF PUBLIC SAFETY


