WHEREAS, the Council of The City of San Diego has adopted the Single-Family Neighborhood Protection Ordinance (O-17250) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on October 19, 1989, the Planning Commission of The City of San Diego held a public hearing to consider approving and recommending City Council adoption of maps classifying protected single-family neighborhoods in Pacific Beach; and


WHEREAS, the Council has considered all maps, exhibits and written documents contained in the file for this project on file in the office of the City Clerk, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby approves the protected single-family neighborhood map for Pacific Beach.

BE IT FURTHER RESOLVED, that the Council hereby releases from the provisions of the Single-Family Neighborhood Protection Ordinance (O-17250) those areas not mapped for classification as protected single-family neighborhoods in the Pacific Beach community to be effective upon the effective dates of the

rezonings adopted by Ordinance No. 0-17577, a copy of which  
is on file in the office of the City Clerk as Document No.  
00-17577.
