BE IT RESOLVED, by the Council of The City of San Diego that the low bid of EUGENE CARTER ENTERPRISES, INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing the SAN DIEGO POLICE DEPARTMENT WITH JANITORIAL SERVICES AT VARIOUS LOCATIONS as may be required for a period of one (1) year beginning November 1, 1990 through October 31, 1991, for a total estimated annual cost of \$120,352.62; terms 2% 20 days, with options to renew contract for four (4) additional one (1) year periods with increases not to exceed 12% of prices in effect at the end of each prior contract period.

BE IT FURTHER RESOLVED, that in the event the Contractor fails to perform in accordance with specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low bidder(s) or to solicit and award emergency bids until the contract can be formally rebid.
