

RESOLUTION NUMBER R- 276896

ADOPTED ON NOV 26 1990

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. INDUSTRIAL SAFETY SHOE CO., 2. KAS SAFETY PRODUCTS, INC. and 3. BOOT WORLD, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for SAFETY FOOTWEAR as may be required for a period of one (1) year beginning December 1, 1990 through November 30, 1991, as follows:

1. INDUSTRIAL SAFETY SHOE CO. for Section I - Low Top Tennis/Jogging Shoes; Section II - High Top Tennis/Jogging Shoes; Section III-A - 6", 8", 10" Boot, Steel Toe; Section III-B - Metatarsal Guards; Section III-C - Boot, Double Leathered Toe; Section III-D - 6", 8", 10" Boot, Nylon, Plastic or Fiberglass Toe/Shank; Section IV-A - Oxford Footwear - Steel; Section IV-B - Oxford Footwear, Nylon, Plastic or Fiberglass Toe/Shank; Section V - Boots, High-Topped, Heavy-Lugged; Section VI - Boots/Shoes, Electrical Hazard. Terms 1% 20 days, plus sales tax, with option to renew for two additional one-year periods, with prices not to exceed 15% of prices in effect at the end of each prior contract period.
2. KAS SAFETY PRODUCTS, INC. for Sections I, II, III-A, III-D, IV-A, IV-B, V and VI. Terms 1% 30 days, plus sales tax, with option to renew for two additional one-year periods, with prices not to exceed 5% of prices in effect at the end of each prior contract period.
3. BOOT WORLD for Sections I, II, III-A, III-B, IV-A, V and VI. Terms net 30 days, plus sales tax, with option to renew for two additional one-year periods, with prices not to exceed 10% of prices in effect at the end of each prior contract period.
