BE IT RESOLVED, by the Council of The City of San Diego that the low bid of ESTATES SECURITY PATROL, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing GUARD SERVICE AT THE MIRAMAR LANDFILL as may be required for a period of one (1) year beginning November 1, 1990 through October 31, 1991 at a cost of \$8.50 per hour, for a total estimated cost per year of \$47,668.00; terms 3% 10 days, with options to renew the contract for four (4) additional one (1) year periods, with price escalations not to exceed 2% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED, that in the event the Contractor is unable to perform in accordance with the specifications, the Purchasing Agent is hereby authorized to terminate the contract and to award to the next low responsible and responsive bidder, and to subsequent bidders, if necessary, until a bidder is found who complies with the specifications.
