WHEREAS, The City of San Diego is the owner of Lot 53, Bonnie Brae; and

WHEREAS, the City desires to negotiate the sale of said land to the STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION, under the provisions of Section 22.0902 of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by CalTrans independent fee appraisal on March 13, 1990, is FIVE THOUSAND NINE HUNDRED TWENTY-THREE DOLLARS (\$5,923); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:



BE IT FURTHER RESOLVED, that the City Manager or his designee is hereby authorized to execute a Right of Way Contract with the STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION, a copy of which Right of Way Contract is on file in the office of the City Clerk as Document No. RR-276910-2 in connection with said Lot 53, Bonnie Brae.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver the deeds and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
