RESOLUTION NUMBER R-276912 ADOPTED ON NOV 261990

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution where the portion of street to be vacated is excess to the City's right-of-way needs and is no longer required for street or highway purposes; and

WHEREAS, the abutting property owners have requested the vacation of portions of Old Quarry Road and Questor Place in connection with the development of Montecito at Mission City (PRD 88-0979) to facilitate development of their property; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, there is no present or prospective use for the street either for the public street system, for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, it is necessary and desirable that the vacation be conditioned upon the dedication of necessary right-of-way for Old Quarry Road and Questor Place; and

WHEREAS, the public street system for which the right-ofway was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That portions of Quarry Road and Questor Place in connection with the development of Montecito at Mission City (PRD 88-0979), as more particularly shown on Drawing No. 17480-1&2-B, on file in the office of the City Clerk as Document No.
- RR-276912 , which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That the resolution shall not become effective unless and until the required dedication for Old Quarry Road and Questor Place has been accepted through Council action. In the event that the dedication is not approved within one (1) year after adoption of this resolution, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned dedication, and the City Clerk shall then cause a certified copy of this resolution, with

drawing, attested by him under seal, to be recorded in the office of the County Recorder.
