2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF PENASQUITOS BRANCH LIBRARY.

4. That the expenditure, not to exceed \$8,372,800 (\$4,186,400 from CIP No. 35-056.0 PENASQUITOS BRANCH LIBRARY, \$2,000,000 from Fund No. 392046 and \$2,186,400 from FBA Fund No.

4. That the expenditure, not to exceed \$8,372,800 (\$4,186,400 from CIP No. 35-056.0 PENASQUITOS BRANCH LIBRARY, \$2,000,000 from Fund No. 392046 and \$2,186,400 from FBA Fund No.

79004), is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
