
RESOLUTION NUMBER R-276920

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 5-year sublease agreement, with an option of an additional 19 months, with ENERGY FACTORS INCORPORATED, for use by the City's Clean Water Program of 21,052 square feet of office space in First Interstate Bank Building, at a rental of \$167,363.40 for the period February 1, 1991 through June 30, 1991, under the terms and conditions set forth in that sublease agreement on file in the office of the City Clerk as Document No. RR-276920.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$167,363.40 from Fund 40012, Dept. 700, Org. 113, Object Account 4682, Job Order 0007101, solely and exclusively for the above purpose, is hereby authorized and approved.
