WHEREAS, on November 21, 1990, the Rules Committee reviewed Department of Legislative Services Report No. 90-38 (as amended) regarding proposed legislation for sponsorship by The City of San Diego; and

WHEREAS, the Rules Committee reviewed the six proposals for sponsorship which include creation of the San Diego Metropolitan Sewage District, penalty enhancement for child endangerment in drug activity, authority to impound vehicles being operated by persons who have outstanding failure to appear warrants, clarification of the requirements related to relocation payments to mobilehome owners, clarification of the maintenance of effort requirements for transportation funds under Proposition 111 and 108, and strengthening laws related to rent skimming; and

WHEREAS, after discussion of the sponsorship proposals, the Rules Committee approved the proposals and assigned them to the appropriate City Council Committee for monitoring during the legislative process; NOW, THEREFORE,
