WHEREAS, on November 11, 1990, the Council of The City of San Diego considered the appeal of Victor and Celia Liu, by Robert A. Ball, Attorney, from the decision of the Historical Site Board in approving historical site designations of the Shaffer, Jones and Silberhorn/Hord Houses as Site Numbers 252, 253 and 254, Grade 3, respectively, with the subject properties being located at 1665 Union Street, 1658-68 Front Street and 205 West Date Street, in the City of San Diego; and

WHEREAS, in arriving at their decision, the City Council considered the decision of the Historical Site Board, the staff report, materials submitted prior to and at the public hearing and heard testimony at the hearing; and

WHEREAS, the City Council found that the appeal could not be granted in that the three houses had historical and architectural merit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of Victor and Celia Liu, by Robert A. Ball, Attorney, in this matter is denied and the decision of the Historical Site Board is hereby affirmed.
