BE IT RESOLVED, by the Council of The City of San Diego, and it is hereby certified, that the information contained in ENVIRONMENTAL IMPACT REPORT DEP NO. 88-0967, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto, and that the Report has been reviewed and considered by this Council.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that pursuant to California Public Resources Code Section 21081, the City Council hereby adopts the findings made with respect to the feasibility of the mitigating measures, project alternatives and the statements of overriding considerations, if any, contained within ENVIRONMENTAL IMPACT REPORT DEP No. 88-0967, on file in the office of the City Clerk.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to proceed with the acquisition of mitigation property in accordance with the ENVIRONMENTAL IMPACT REPORT, DEP No. 88-0967, and continue with the design of Jackson Drive to SR-52, CIP 52-431.0.

BE IT FURTHER RESOLVED, that the City Manager is authorized to continue to design the Jackson Drive extension by completing the final plans, specifications and estimates for the construction of the project. These plans, specifications and


estimates shall include the traffic signal at Cowles Mountain Boulevard and Jackson Drive.

BE IT FURTHER RESOLVED, the City Manager is hereby requested to consider the prohibition of heavy vehicles upon the Mission Trails Parkway.
