NAME(S): Eugene Amy  
DEPARTMENT: Water Utilities/Systems Division  
AMOUNT: \$795.14  
SUGGESTION: Mr. Amy is a Senior Water Utilities Supervisor with the Water Utilities Department. He suggested the installation of on-site fuel tanks at the Miramar operations station. This is expected to save \$5,300 during the first year of installation. This is a partial award pending a final 12 month review.

NAME(S): Hirendira Sandoval  
DEPARTMENT: General Services/Street Division  
AMOUNT: \$2,040.00  
SUGGESTION: Mr. Sandoval is a sign painter with the Street Division of General Services. He suggested refacing parking signs with pressure sensitive decals instead of replacing them. This is expected to save \$13,600 annually in time, material, and equipment. This is a partial award pending a final 12 month review.
