RESOLUTION NUMBER R- 276948

ADOPTED ON NOV 05 1990

WHEREAS, an amendment to the Scripps Miramar Ranch Community Plan was adopted on October 31, 1988 reflecting the closure of a portion of Pomerado Road between Semillon Boulevard and the City of San Diego/City of Poway border, and

WHEREAS, such action being a "project" subject to the provisions of the California Environmental Quality Act ("CEQA"), an Environmental Impact Report, associated findings and a Statement of Overriding Considerations was certified and adopted on October 31, 1988, and

WHEREAS, that portion of Pomerado Road has been closed and reconstructed since November of 1988, and

WHEREAS, the reconstruction of that portion of Pomerado Road is nearing completion, and

WHEREAS, the Council of the City of San Diego finds that substantial changes have occurred with respect to the circumstances under which the project was originally undertaken and new information has been available which was not known at the time of the certification of the original EIR for the project which will require the preparation of new environmental documents, and

WHEREAS, the public health, safety and welfare of the citizens of San Diego will be adversely affected because of the anticipated dramatic and substantial increase in traffic on Pomerado Road between Semillon Boulevard and its juncture with I-


15, in amounts well in excess of its design capacities, if Pomerado Road is opened upon its completion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed not to reopen that portion of Pomerado Road between Spring Canyon Road and the City of San Diego/City of Poway border when the reconstruction is completed unless otherwise instructed by this City Council.

BE IT FURTHER RESOLVED, that the City Clerk and the Planning Director be and they are hereby directed to cause an appropriate notice be given concerning a proposed amendment to the Scripps Miramar Ranch Community Plan and any proposed reopening of Pomerado Road and that prior to any consideration by this City Council of a reopening that full and complete compliance with the provisions of the California Environmental Quality Act be had.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby requested to work closely with the City of Poway and the Scripps Miramar Ranch Community to mitigate traffic impacts in the Community should Pomerado Road be opened.
