BE IT RESOLVED, by the Council of The City of San Diego that the sole bid of BIOCUM INCORPORATED, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SEVEN (7) DUPLEX/MULTIPLEX CORONARY OBSERVATION RADIO UNITS (Biocom Model 3550-12) at a cost of \$7,700 each, and four (4) AC Chargers (Biocom Model 3552-AC) at a cost of \$600.00 each, for a combined total cost of \$56,300.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$60,381.75, from Department No. 120, Fund No. 100, Object Account No. 6010, and Job Order No. 6100, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


