ABABA BOLT, INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of HARDWARE AND FASTENERS as may be required for a period of one (1) year beginning November 1, 1990 through October 31, 1991, per prices on file in the Purchasing Department as follows:

1. KAR PRODUCTS, INC. for Section I - Bolts, Washers, Nuts, Screws, All-threads, for a total estimated annual cost of \$25,327.00; terms net 30 days, plus sales tax, with options to renew the contract for two (2) additional one (1) year periods with increases not to exceed 3% of prices in effect at the end of each prior contract period.
2. ABABA BOLT, INC. for Section II - Stainless Steel Fasteners, for a total estimated annual cost of \$37,761.00; terms net 30 days, plus sales tax, with options to renew the contract for two (2) additional one (1) year periods with increases not to exceed 10% of prices in effect at the end of each prior contract period.


