

RESOLUTION NUMBER R- 276959

ADOPTED ON DEC 1 0 1990

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE IMPROVEMENT OF REO DRIVE FROM STATE ROUTE 54 TO RANCHO HILLS DRIVE, filed in the office of the City Clerk of The City of San Diego, California, on

DEC 1 0 1990, and bearing official Document No.

W.O. 118779 be and the same are hereby approved.

2. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for THE IMPROVEMENT OF REO DRIVE FROM STATE ROUTE 54 TO RANCHO HILLS DRIVE.

4. That the City Auditor and Comptroller is hereby authorized to transfer \$50,000 from CIP No. 58-004, MISCELLANEOUS

REQUIREMENTS - CITY STREETS FROM CAPITAL OUTLAY to CIP No. 52-283.0 IMPROVEMENT OF REO DRIVE - STATE ROUTE 54 TO RANCHO HILLS DRIVE.

5. That the expenditure, not to exceed \$1,040,300 (\$557,300 from Fund No. 73-195.0, BONITA PIPELINE; and \$483,000 from CIP No. 52-283.0 IMPROVEMENT OF REO DRIVE - STATE ROUTE 54 TO RANCHO HILLS DRIVE) is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


